Showcase Rules & Requirements

1. CCBA Membership is required to participate in the Citrus Showcase of Homes and you must have a model and/or sales office in Citrus County
2. Entries are not considered valid until all forms are complete and payment is received in full. Entries received after Dec 3, 2018 have no guarantee of advertising. All fees are non-refundable.
3. Entrant must submit high quality artwork of model floor plans and elevations. Upon receipt of your entry, CCBA will forward model information forms to be completed and included with artwork.
4. Certificate of occupancy must be issued no later than February 13, 2019 to be eligible for judging.
5. All trash and building debris must be removed from participating site no later than February 13, 2019 to be eligible for judging.
6. Showcase entry must be open for public viewing with representative present during all designated event hours, which are 10am -5pm, Monday thru Saturday and 12pm-5pm on Sunday.
7. All participants must allow committee approved sponsor collateral in entry, model or office during Showcase hours/dates.

8. Showcase of Homes signs are the official property of the CCBA. One large entry sign and 6 small directionals will be allotted for each entry. A refundable deposit of \$150 per entry is required for signs. Deposits will be refunded when all signs are returned to the CCBA office no later than March 14, 2019. Missing signs must be reported to CCBA immediately to receive deposit refund.
9. Showcase models shall not be occupied by buyer or tenant until after March 3, 2019, when the Showcase ends. Entries that were previously in the Showcase are welcome.
10. The Showcase Committee is the final authority on all rules, disputes, and decisions regarding the Showcase of Homes. All items are subject to change at any time by majority vote of the committee.
11. Failure to comply with any portion of this agreement may render my company ineligible for future participation in the Showcase, for up to 3 years and will forfeit any entry fees or portion thereof.
12. All entrants agree to indemnify and hold harmless the Citrus County Building Alliance (CCBA), its agents, employees, committee members, and all event sponsors from any claims, causes of action, or judgments of any kind which may arise from or relate to the company's participation in the Showcase of Homes. Entrants will promptly undertake responsibility for any losses arising from claims and fees or final judgments.
