Virtual Show Terms and Conditions

1. CITRUS COUNTY'S ORIGINAL HOME SHOW (herein called "Show") is to be in a virtual format for Fall 2020 and Spring 2021. Show is managed and operated by the Hometown Citrus and Citrus County Building Alliance (herein called the "organizer").

2. CONTRACT CONDITION: It is the responsibility of the participating company, hereafter called the "Vendor", to guarantee personal ownership of and legal right to use all digital materials provided to the Organizer for show advertising and promotion.

3. VIRTUAL SPACE RESERVATIONS: The application for virtual exhibit space must be signed by a duly authorized agent of the exhibitor and accompanied by 100 percent of the total fee no later than November 6. Any payment made shall not be refundable if the exhibitor cancels virtual space after November 6, 2020. Notice of cancellation must be received by the organizer in writing. Only cancellation of event by organizer will merit full refund of exhibit space. Vendor must provide any and all digital materials for virtual space.

3b. MAINTENANCE OF VIRTUAL SPACE - Exhibitors shall have someone available to address any issues that arise during live time spots, or with digital links, website links, etc.

in the event that attendees have issues when trying to access participant promotions and sites. Organizer will not be held responsible for issues that occur on the Vendors end.

4. PRIZE DRAWINGS: Each exhibitor is encouraged to provide a giveaway and utilize scheduled Live time in the attendees Facebook Group to promote giveaway. Vendor shall give Organizer full details of giveaway for inclusion in show promotion.

5. PUBLICITY: Organizer will provide advertising, public relations, and other activities to promote Citrus County's Original Home Show. Organizer will provide virtual space with links to Vendor's website or Facebook page of choice. Organizer will provide public access to "Attendees Group" where Vendor will have scheduled times to promote their business with posts or Live Interactive options. Vendor agrees to keep any attendee information supplied by Organizer for Vendor use only and not to supply to 3rd parties.
